## AGREED FINAL JUDGMENT ORDER

THIS CAUSE COMING TO BE HEARD on the agreement of all parties to this cause to enter an Agreed Final Judgment Order, the parties having reported to the Court that they have settled, compromised, adjusted, and adjourned all matters and issues between them pertaining to the above entitled cause; and the parties having further reported to the Court that they have agreed to and consent to be bound by the terms of the agreement hereinafter set forth; and the Court being fully advised in the premises:

NOW THEREFORE, UPON AGREEMENT OF THE PARTIES HERETO, THE COURT FINDS AND ORDERS AS FOLLOWS:

- 1. Respondent Michelle Ann Cummins is hereby found to be in minor indirect criminal contempt of court for engaging in the unauthorized practice of law by accepting a position as "Associate Counsel" at UnitedHealthcare, working in that position from an office in Chicago, and holding herself out as an attorney in the State of Illinois.
- 2. Respondent Michelle Ann Cummins is hereby sentenced to one year of non-reporting probation and a fine of \$500.
- 3. Respondent Michelle Ann Cummins is hereby permanently enjoined from engaging in any acts of unauthorized practice of law in Illinois by holding herself out as an attorney, lawyer, or counselor at law in this State, or by undertaking the provision of legal advice or services on behalf of others in this State, without first obtaining authorization from the Illinois Supreme Court to practice law.

4. That this Court reserves and retains jurisdiction over the above-entitled action for the purpose of permitting the parties to this Agreed Final Judgment Order to apply to this Court for such further orders and direction as may be necessary for the enforcement of this Agreed Final Judgment Order.
